

KIDSCAMP WAIVER 2011-2012

PLEASE READ & SIGN THE FOLLOWING:

I the parent/guardian of the previously named minor(s) agree & understand that skiing is a hazardous activity. I recognize the risks inherent in the sport of skiing, including but not limited to paralyzing injuries and death. I hereby give consent for the minor to participate in the Kidscamp program and hereby agree on behalf of the said minor and for myself to indemnify and hold harmless the State of New York & the New York State Department of Environmental Conservation (NYSDEC) & Belleayre Mountain Ski Center, their employees, representatives, assigns, sponsors and suppliers to the Kidscamp program against any liability, claims, actions, demands, and proceedings in law or equity, including derivative actions which arise from or are in any way attributable to the minor's participation in skiing/riding lessons. For and on behalf of the said minor, and for myself, I also hold harmless and indemnify the State of New York, NYSDEC & Belleayre Mountain, from any liability, claims, actions, demands and proceedings in law or equity including derivative actions which may arise or are attributable to the participant's actions.

I certify that the previously named minor is physically and emotionally ready to participate in this program and is of the specified age & that my child is prepared for a full day experience away from his/her guardian. I agree to have my child's personal equipment fully checked prior to arrival and that by signing this agreement I acknowledge that if my child's equipment malfunctions, I authorize Kidscamp staff to select and sign for rentals from the Kidscamp rental shop. I understand I will be responsible to pay for the rental at end of day. I understand that cancellations & date changes should be made at least 48 hours prior to arrival. Kidscamp reserves the right to cancel any future reservations for failure to adhere to the cancellation policy. I understand Kidscamp check in time for **Session 1** is from 8am - 8:30am Walk-ins will be addressed after check in between 8:30& 8:45am and that sign out for the day is at 2pm. I understand Kidscamp check in time for **Session 2** is from 9:45am- 10:15am. Walk-ins will be addressed after check in between 10:15am & 10:30am and sign out for the day is at 3:30pm. I understand that late arrival & check-in may result in denial of enrollment into the program for that day. I (or an assigned guardian) agree that I will be on Belleayre premises while my child is enrolled in Kidscamp. I realize my child may not always ride/ski lifts with their instructor or an adult and may ride alone or with another child. I understand that should I opt to purchase a two day ticket there is no refund for a second day no show. Additionally, I must display the child's ticket upon arrival (as it is the same ticket that was issued the previous day). I understand lesson times may include, but are not limited to rest periods, cold weather breaks, or playtime depending on the needs of the group. I understand it is my responsibility to dress my child appropriately, in order for my child to participate in the program & that it is my responsibility to label all personal belongings prior to arrival. I realize that if my child refuses to participate in the program he/she will be allowed to remain indoors with a care giver & that no refund or credit will be issued. I have realistically evaluated my child's skiing or snowboarding skills. I understand that once I have paid and completed all paperwork that my child will enter the Kidzone. I realize that for security reasons parents are not permitted in the Kidzone until the end of the day. I fully understand that the Kidscamp staff will determine the group & ability level of my child, & place my child with safety as a primary concern. Should my child not be able to perform to the previously named level, Kidscamp Staff reserves the right to move my child to the appropriate level. I understand that Kidscamp staff will not administer medications & that it is my responsibility to administer any medication during lunch time. I understand that in the event of an accident or injury that medical care can be given to my child by Ski Patrol. I understand that I/guardian will be issued a numbered card that matches my child's numbered card for child pickup & must present it to instructor at the end of the Kidscamp day. I understand that I must be at Kidscamp at 2:00pm to pick up my child from session 1 and at 3:30pm to pick up my child from session 2 I understand that it is my responsibility to return my child's equipment at the end of the day. In the event that my child is dropped off or picked up by someone other than myself, I understand that the assigned person must present the day's numbered card or provide proof of identification matching a name listed on the previous page. I understand that Kidscamp staff reserve the right to refuse or decline acceptance into the program based on the child's mental & physical readiness or if the said child is unwilling to abide by the safety, guidelines & respect of others. I understand that it is not our policy to issue refunds or rain checks for any reason.
